#### Introduction

## What is malpractice and maladministration?

'Malpractice' and 'maladministration' are related concepts, the common theme being that they involve a failure to follow the rules of an examination or assessment. This policy and procedure uses the word 'malpractice' to cover both 'malpractice' and 'maladministration' and it means any act, default or practice which is:

- a breach of the Regulations, and/or
- a breach of awarding body requirements regarding how a qualification should be delivered, and/or
- a failure to follow established procedures in relation to a qualification

which:

- · gives rise to prejudice to candidates, and/or
- · compromises public confidence in qualifications, and/or
- compromises, attempts to compromise or may compromise the process of assessment, the integrity of any qualification or the validity of a result or certificate, and/or
- damages the authority, reputation or credibility of any awarding body or centre or any officer, employee or agent of any awarding body or centre (SMPP 1)

#### **Candidate malpractice**

'Candidate malpractice' normally involves malpractice by a candidate in connection with any examination or assessment, including the preparation and authentication of any controlled assessments, coursework or non-examination assessments, the presentation of any practical work, the compilation of portfolios of assessment evidence and the completion of any examination. (SMPP 2)

#### Centre staff malpractice

'Centre staff malpractice' means malpractice committed by:

- a member of staff, contractor (whether employed under a contract of employment or a contract for services) or a volunteer at a centre, or
- an individual appointed in another capacity by a centre such as an invigilator, a Communication Professional, a Language Modifier, a practical assistant, a prompter, a reader or a scribe (SMPP 2)

# **Suspected malpractice**

For the purposes of this document, suspected malpractice means all alleged or suspected incidents of malpractice (regardless of how the incident might be categorised, as described in SMPP, section 19). (SMPP 2)

# Purpose of the policy

To confirm North Leamington School:

has in place for inspection that must be reviewed and updated annually, a written malpractice policy which
covers all qualifications delivered by the centre detailing how candidates are informed and advised to
avoid committing malpractice in examinations/assessments, how suspected malpractice issues should be
escalated within the centre and reported to the relevant awarding body; it must also acknowledge the use
of AI (e.g. what AI is, when it may be used and how it should be acknowledged, the risks of using AI, what
AI misuse is and how this will be treated as malpractice) (GR 5.3)

# **General principles**

In accordance with the regulations North Leamington School will:

- take all reasonable steps to prevent the occurrence of any malpractice (which includes maladministration) before, during and after assessments have taken place (GR 5.11)
- inform the awarding body immediately of any alleged, suspected or actual incidents of malpractice or maladministration, involving a candidate or a member of staff, by completing the appropriate documentation (GR 5.11)
- as required by an awarding body, gather evidence of any instances of alleged or suspected malpractice
  (which includes maladministration) in accordance with the current JCQ document Suspected Malpractice Policies and Procedures and provide such information and advice as the awarding body may reasonably
  require (GR 5.11)

# **Preventing malpractice**

North Leamington School has in place:

- Robust processes to prevent and identify malpractice, as outlined in section 3 of the JCQ document Suspected Malpractice: Policies and Procedures. (SMPP 4.3)

#### Informing and advising candidates how to avoid committing malpractice in examinations/assessments

- Students are informed of malpractice through assemblies (conducted by Year Lead and SLT) and tutor times focussed on examinations/NEA.
- These assemblies include the use of AI, detailing what it is, when and how it may be used and if used, how it should be referenced together the consequences of using AI improperly.

- JCQ posters and presentations are used in these assemblies and tutor time sessions.
- Teachers delivering NEA also remind students of these expectations.
- Information from JCQ can also be found on the Exams page of our website for students to refer to.

#### Al use in assessments

### **AI USE AND TOOLS**

•

Al use in this context refers to the use of Al tools to obtain information and content which might be used in work produced for assessments, which contributes to the award of qualifications.

Al misuse is where a student has used one or more Al tools but has not appropriately acknowledged this use and has submitted work for assessment when it is not their own.

When properly referenced, the use of AI can be acceptable, although students cannot be credited for any work they produce for assessment that is not their own so the benefit to them using AI is likely to be limited and they risk committing malpractice if AI is misused.

Staff working with students on a regular basis and are familiar with their ability and standard of work are usually best placed to make determinations about the misuse of AI tools. Through using internal assessment practice such as moderation of work and grading, the subject teacher will use a range of strategies to mitigate any misuse.

Suspected use

of AI should follow the internal policies of the NLS internal behaviour policy.

Al is part of

our digital literacy curriculum in school about how they are educated.

With reference to the JCQ guidance for Teachers & Assessors - Al Use in Assessments: Protecting the Integrity of Qualifications:

Students complete the majority of their exams and a large number of other assessments under close staff supervision with limited access to authorised materials and no permitted access to the internet. The delivery of these assessments should be unaffected by developments in Al tools as students must not be able to use such tools when completing these assessments.

There are some assessments in which access to the internet is permitted in the preparatory, research or production stages. The majority of these assessments will be Non-Examined Assessments (NEAs), coursework and internal assessments for General Qualifications (GQs) and Vocational & Technical Qualifications (VTQs). JCQ's guidance which is designed to help students and teachers to complete NEAs, coursework and other internal assessments successfully is followed in relation to these assessments.

If students are found to be using AI inappropriately, against the advice given to students, based on JCQ guidelines, the following

Internal procedures will be followed-

- The student will meet with SLT in Charge of Examinations, or a colleague designated by them, to discuss findings.
- The students parent/carer will be informed.
- NLS internal behaviour policy, as appropriate, will be followed.
  - If appropriate, the student will be given resources/time/a further opportunity to replace the work.
- JCQ regulations will be followed, if the student is found to have used AI inappropriately, after signing the declaration that the work is their own.
  - If the student is found to have utilised AI on a subsequent occasion, the school reserves the right to remove the student

From the relevant qualification(s) to protect the integrity of the centre.

# Identification and reporting of malpractice

#### **Escalating suspected malpractice issues**

Once suspected malpractice is identified, any member of staff at the centre can report it using the appropriate channels. (SMPP 4.3)

If a member of staff suspects malpractice, they should inform their line manager and ensure this is report to the Exams Officer or SLT member in charge of exams. They will then investigate in line with JCQ procedures and discuss with the Head of Centre who will report as appropriate.

#### Reporting suspected malpractice to the awarding body

- The head of centre will notify the appropriate awarding body immediately of all alleged, suspected or actual incidents of malpractice, using the appropriate forms, and will conduct any investigation and gathering of information in accordance with the requirements of the JCQ document **Suspected Malpractice: Policies and Procedures** (SMPP 4.1.3)
- The head of centre will ensure that, where a candidate is a child or an adult at risk and is the subject of a malpractice investigation, the candidate's parent/carer/ appropriate adult is kept informed of the progress of the investigation (SMPP 4.1.3)
- Form JCQ/M1 will be used to notify an awarding body of an incident of candidate malpractice. Form JCQ/M2 will be used to notify an awarding body of an incident of suspected staff malpractice/maladministration (SMPP 4.4, 4.6)
- Malpractice by a candidate discovered in a controlled assessment, coursework or non- examination
  assessment component prior to the candidate signing the declaration of authentication does not need to
  be reported to the awarding body but will be dealt with in accordance with the centre's internal
  procedures. The only exception to this is where the awarding body's confidential assessment material has
  potentially been breached. The breach will be reported to the awarding body immediately (SMPP 4.5)
- If, in the view of the investigator, there is sufficient evidence to implicate an individual in malpractice, that individual (the candidate or the member of staff) will be informed of the rights of accused individuals (SMPP 5.33)
- Once the information gathering has concluded, the head of centre (or other appointed informationgatherer) will submit a written report summarising the information obtained and actions taken to the relevant awarding body, accompanied by the information obtained during the course of their enquiries (5.35)
- Form JCQ/M1 will be used when reporting candidate cases; for centre staff, form JCQ/M3 will be used (SMPP 5.37)
- The awarding body will decide on the basis of the report, and any supporting documentation, whether there is evidence of malpractice and if any further investigation is required. The head of centre will be informed accordingly (SMPP 5.40)

# Communicating malpractice decisions

Once a decision has been made, it will be communicated in writing to the head of centre as soon as possible. The head of centre will communicate the decision to the individuals concerned and pass on details of any sanctions and action in cases where this is indicated. The head of centre will also inform the individuals if they have the right to appeal. (SMPP 11.1)
