Dear Parents, Carers

Happy New Year!

I hope the break and festive season was a good one for you all.

This letter contains some key reminders as well as pointers for things you need to be aware of as we move in to the new calendar year and begin to approach some of the key challenges of the academic year.

1. Examination Season, Data and Support

The specific exam schedule for Y12 and Y13 Mocks will be issued soon – recall the examination window straddles February half-term for necessary logistical reasons.

Please recall that we are always here to support with the stresses and strains your children face, whether exam-related or otherwise. We are also happy to advise you on how you might help your children. The next tranche of examinations will feed in to G4S and Data 2 near Easter, upon which we will identify any additional academic and pastoral support needs – in addition to those which have been put in place after Data 1 or at any other point. Of course, you need not wait for these data windows to let us know of any support you may feel is needed.

2. UCAS and Future Pathways

The Y13 internal deadline for UCAS submissions has now passed – we are in process of working with those remaining few Y13 who can still meet the external UCAS deadline towards the end of January. We are pleased that over 100 applications have been made already and that there are so many offers being given which will help incentivise our Y13.

Recall that Y12 can always start the process now if they choose – though the formal Future Pathways launch (which includes guidance on UCAS but also apprenticeships, gap years and employment) will be in the last half-term. Please refer to the links issued previously and to students.

Before then, we have lots of excellent Careers opportunities available to our Sixth Form students – including provision in Apprenticeships Week this term and via opportunities afforded by our terrific Careers Team.

3. Polite Requests and Reminders

Where we sympathise with demands on time and look to be as flexible as is reasonably possible, we would ask that parents continue to support us in ensuring learning in the classroom remains paramount by avoiding making requests for Open Day visits or Driving Theory Tests: universities generally make Open Days available at weekends and in holidays, while we understand that Driving Theory Tests are generally available (if perhaps limited) at a range of times so do not need to be undertaken in school time. It remains fine to request time off for a Practical Driving Test as these are set centrally with no time options given.
