Dear Parent/Carer,

Year 10 BTEC Dance Coursework Assessments

I am writing to provide you with some information on the externally set, internally completed coursework your child will complete for BTEC Dance in the upcoming weeks.

Over the course of Year 10 and Year 11 your child will complete three different components for BTEC Dance. The first component to be completed this academic year is Component 2 – *Developing skill and techniques in the Performing Arts*. This component is worth 30% of the BTEC Dance qualification. Most of the coursework will be completed during timetabled BTEC Dance lessons. There are additional sessions in place to support your child with the completion of this coursework highlighted below. If your child is entitled to any access arrangements for their exams then these will also be applied to all sections of the component throughout the assessment window.

Below identifies the tasks for Component 2 with some teacher context of what your child will be completing during this time:

| Task 1 | Rehearsals Use rehearsal processes | Supervised rehearsals of an existing professional repertoire (All that Jazz) where students will work in groups to learn a professional dance work. The coursework for this task will be filmed video footage of rehearsals and a written rehearsal log. |
| Task 2 | Performance Apply skills and techniques in performance | Students will perform the professional repertoire with their group in the Main Theatre and the evidence for this coursework will be a video recording of All that Jazz. |
| Task 3 | Evaluation Review own development and application of performance skills | Students will complete an evaluation of their performance and rehearsals in a written document which will be completed in a computer room in exam conditions. |

After all of the coursework has been completed it will be marked and moderated internally and then it will be sent off to be externally moderated by the Pearson BTEC exam board. Your child will receive a raw mark out of 60 for Component 2 which will then be converted to a percentage to provide an overall assessment grade for each component (ranging from a Level 1 Pass to a Level 2 Distinction).

Depending on how well students do across the country will depend on where the component grade boundaries sit.

As mentioned, all the coursework completed during this assessment window will contribute towards their final grade and it is crucial that your child remains focused and motivated in lessons. Any support and encouragement that can be provided at home would be incredibly beneficial to your child during this assessment period.
