# **Iceland Trip Final Reminders**

We are all very much looking forward to our Iceland trip, a few final reminders for you.

# Luggage

The luggage allowance is 22kg and the maximum dimensions for hand luggage is 56 x 45 x2 5cm. The travel company has confirmed that we will be getting straight onto a coach after arriving in Iceland and therefore students should wear clothes on the first day suitable for the climate in Iceland. We suggest that if your child has walking boots, but if they do not want to wear these on the plane they put them at the top of their suitcase where they can easily and quickly access them upon arrival.

### Currency

The currency in Iceland is krona; if your child is bringing cash please ensure it is are ordered in advance from a currency exchange bureau. It will be the students' responsibility to look after their own money.

Total admission fee to the two bathing pools is less than £5 (approximately 620 krona). If you child wishes to purchase additional items such as souvenirs please provide additional spending money but do bear in mind it is an expensive location.

#### **Data, Wi-Fi and Phones**

In terms of access to data and Wi-Fi do check with their network provider before travel.

Phones may be used for photos (not checking social media, gaming or scrolling etc) while out and about visiting the sights. Students must gain permission from other students before they take a photo and are not to take photos of staff. No photos are to be posted to social media during the trip or after. The responsibility for having a phone is with the student please ensure your own insurance covers any loss or damage.

#### **GHIC**

A GHIC is recommended (UK Global Health Insurance Card), this is free of charge and can be applied for at Applying for healthcare cover abroad (GHIC and EHIC) - NHS.

#### Medication

In terms of medicine, parents/ carers must acquaint themselves with the policy here on our website: Link to Policy on Supporting Students with Medical Needs.

Parents/ carers will need to ensure they pass on all medicines (prescription or over-the-counter ones) with a copy of the Parental Agreement (consent) form found on page 6 to either of us (Mr Wiliams or Mrs Ashton) before we set off.

If you should require a paper copy of the form you child can collect one from either of our classrooms or the Humanities office (middle floor).

















### **Passports**

Please ensure their passport is packed into their bag/rucksack, we will check these upon arrival to school at 5.00 am on Thursday 10 April and the coach will depart at 5.15am.
