Dear Parent/Carer,

Y11 BTEC Travel and Tourism Pearson set Assignments

I am writing to provide you with some information on the externally set, internally completed coursework your child will complete for BTEC Travel and Tourism in the upcoming weeks.

Over the course of Year 10 BTEC students completed component 1 (worth 30%) and now in Year 11 your child will complete the remaining two components, one of which is coursework the other of which is a formal exam in the summer. Component 2, which begins next week, will look at Customer Needs in Travel and Tourism. This component is worth 30% of the BTEC Travel and Tourism qualification. The coursework assessment window for Component 2 will run between the *w/c 07 October–w/c 18 November 2024*. Most of the coursework will be completed during timetabled BTEC Travel and Tourism lessons with the vast majority of it being sat in exam conditions on computers. There are additional sessions in place to support your child with the completion of this coursework highlighted below and reminders of these sessions will be group called closer to the time. If your child is entitled to any access arrangements for their exams for example, additional time and support with reading then these will also be applied by the teacher throughout the assessment window. In addition, your child's classroom notes can be taken into each coursework session during the assessment window and should be utilised to support them with completing all of their coursework set tasks.

Below are the five tasks for Component 2 with some context of what your child will be completing during this time:



Students will carry out research and then produce an extended piece of writing to consider how different-sized airports meet the needs of solo travellers with visual impairments. The scenario will be given by the exam board.
Task 3a	Learning Aim B — Recognise how the needs and preferences of travel and tourism customers are met.	This piece of coursework will be typed on the computer and presented on a word document or PowerPoint presentation. Students will refer to a given visitor profile and will complete a detailed travel plan that meets the needs and preferences of the group. The travel plan must include: • travel dates and duration • accommodation details • transport details • breakdown of costs including the total cost • details of how the information in your travel plan meets the group's needs and preferences
Task 3b	Learning Aim B - Recognise how the needs and preferences of travel and tourism customers are met.	The scenario will be given by the exam board. After all of the work has been completed it will be marked and moderated internally by the Year 11 BTEC Travel and Tourism teachers (Ms Ellis, Mrs Ashton & Mr Williams) and then will be sent off to be externally moderated by the Pearson BTEC Travel and Tourism exam board.

Your child will receive a raw mark out of 60 for all four tasks together which will then be converted to a percentage to provide an overall assessment grade (ranging from a Level 1 Pass to a Level 2 Distinction). Depending on how well students do across the country will depending on where the component grade boundaries sit.

As previously mentioned above, all of the coursework that will be completed during this assessment window is worth 30% of the overall qualification for BTEC Travel and Tourism so it is crucial that your child remains focused and motivated in lessons. This will help to ensure that the work completed is to the best possible standard to help secure their overall grade. Any support and encouragement that can be provided at home would be incredibly beneficial to your son/daughter during this assessment period.

A final reminder that there will be an intervention offered weekly **after school** on a **Friday 3:20 - 4:00 in H114** (starting from 11 October) these sessions are available for students with gaps in learning during the PSA window due to lesson absences, and students will be invited to attend these where/when appropriate.
