Dear Parents/Carers

Y10 BTEC Dance Coursework Assessments

I am writing to provide you with some information on the externally set, internally completed coursework your child will complete for BTEC Dance in the New Year.

Over the course of Year 10 and Year 11 your child will complete three different components for BTEC Dance. The first component to be completed is Component 2 – *Developing Skills and Techniques for the Performing Arts.* This component is worth 30% of the qualification. The coursework assessment window for Component 2 will run between the **w/8 January** – **w/c 4 March 2024**. Most of the coursework will be completed during timetabled BTEC Dance lessons with the vast majority of it being practical in the dance studio with some theoretical work on computers. There are additional sessions in place to support your child with the completion of this coursework highlighted below. If your child is entitled to any access arrangements for their exams then these will also be applied to all sections of the component throughout the assessment window.

Below are the three tasks for Component 2 with some teacher context of what your child will be completing during this time:

Your child will receive a raw mark out of 60 for all three tasks together which will then be converted to a percentage to provide an overall assessment grade (ranging from a Level 1 Pass to a Level 2 Distinction). Depending on how well students do across the country will depending on where the component grade boundaries sit.

As previously mentioned above, all of the coursework that will be completed during this assessment window is worth 30% of the overall qualification for BTEC Dance so it is crucial that your child remains focused and motivated in lessons. This will help to ensure that the work completed is to the best possible standard to help secure their overall grade. Any support and encouragement that can be provided at home would be incredibly beneficial to your child during this assessment period.

A final reminder that there will be an intervention/extra rehearsal opportunity offered weekly **after school** on a **Tuesday 3:20 - 4:30pm in C216 Dance studio** (starting from the 16 January 2024). In these sessions, groups can rehearse independently to refine and practice their professional repertoire.
